Applicant acknowledges receipt of a copy of the current Policies and Procedures and acknowledges that said Policies and Procedures include, among other things, certain waiver of rights and potential claims as stated therein.

By execution of this Application, Applicant specifically acknowledges and agrees:

- a. that the Columbarium and Memorial Plaques shall initially be located on the West side of the Narthex of the Church;
- b. that the long term vision for the Columbarium is to construct a garden space on the Church grounds that will contain the columbarium units and Memorial Plaques (“the Columbarium Garden”); and,
- c. the Columbarium unit and Memorial Plaques initially located in the Narthex of the Church will be transferred to the Columbarium Garden upon its completion, with all costs for such transfer to be paid by the Church.
